

❖ **Cancellation & Refund Rules :-**

Refund of fees by the college after change of college, course or cancellation of admission:

- On or before prescribed date -Rs. 1500/- (Rs. One Thousand Five Hundred only) to be paid in cash as admin fees and all fees will be refunded.

Instructions-

1. Candidate who has joined for postgraduate course either through All India Post Graduate quota or through NEET-PG 2023 state quota should complete Junior residency tenure, failing which he/she will be required to pay non-refundable 10,00,000/- (i.e. for non-completion of Junior residency tenure). However, this is not applicable to the candidates of NEET-PG 2023 resigning the PG admission before prescribed date, which will be notified in due course.
2. Any candidate admitted either through All India Post Graduate quota or through NEET-PG 2023 state quota responsible for lapse of post graduate medical seat will have to pay non-refundable Additional penalty of Rs.10,00,000/-, such candidate will not be eligible for admission through State Quota for subsequent two academic years, i.e NEET PG 2024 & 2025.
3. As per Government Resolution (G.R. No. MED 1010/CR-184/10/Ed-2 dated 28th May 2010 and any G.R issued in this regard from time to time), candidate joining seat of Government/Municipal Corporation colleges for admission to Post graduation Courses either through All India Post Graduate quota or through NEET-PG 2023 state quota will be required to sign a bond to serve the Government of Maharashtra or local self-government or defence services for a period of one year (Social responsibility service), failing which he/she will be required to pay Rs. 50,00,000/- (Rupees fifty lacs only) for the default. **Bond to be submitted immediately after retaining & joining residency in the office.**
4. The candidate who have passed post graduate MD/MS/Diploma from Government /Corporation colleges, have to complete social responsibility service (bond) from either of the institution i.e. Government of India or its undertaking institute (within Maharashtra State) / defence services/Maharashtra State services or its undertaking/self-local Government bodies and their undertaking situated in the state of Maharashtra as per MEDD G.R. No. CET 3518/C.R.32 / 18 / Edu-2, Dated 29/01/2018
5. At the time of commencement of residency for (M.D., M.S.) P.G. students are required to submit P.G. Registration and Enrolment form of MUHS, Nashik University duly signed by the P.G. Teacher and H.O.D. of the concerned Department & Haemogram report to post graduate section, college office within seven days of joining of residency.
6. All candidates are required to join the residency immediately. Extension for joining late will not be granted under any circumstances.
7. Students are required to keep valid Identity Card with them. Please collect the identity card from the college office within a month from joining residency.
8. All applications / request letters will be addressed to Dean, PCMC PGI YCMH Pimpri and forwarded through the proper Channel / H.O.D. concerned.
9. Students are requested to contact concerned Warden regarding Hostel accommodation.
10. They will also have to be abiding by disciplinary rules of Government / PCMC / MUHS and these institutions.
